

Formula 1 Esports Qualification Prize Draw (the "Prize Draw") Terms and Conditions

1. The promoter of this Prize Draw is Formula 1, No. 2 St James's Market, London, SW1Y 4AH (the "**Promoter**").
2. Subject to paragraph 10 below, this Prize Draw is open to residents aged 16 and over of the EU, USA and other territories where its operation and the prizes are permitted. Where operation of this Prize Draw is not permitted by applicable law or regulation, this Prize Draw shall not be operated and residents of such jurisdictions are not permitted to enter.
3. The Prize Draw is not open to: (a) employees, contractors or agents of Promoter, their group companies or family members, freelance contributors, anyone else connected to the Prize Draw and their family members; or (b) public officials (as defined by applicable laws, statutes and regulations relating to bribery and corruption, including but not limited to the United States Foreign Corrupt Practices Act of 1977 and the UK Bribery Act 2010) and anyone connected to them.
4. By entering the Prize Draw you are accepting these terms and conditions (the "**Terms and Conditions**"). These Terms and Conditions shall be effective for all entries into the Prize Draw and shall supersede and extinguish any other terms and conditions relating to the Prize Draw.

6. HOW TO ENTER

- 6.1 The competition will run from 00.01am on 8 April 2019 (the "**Opening Date**") to 23.59pm on 19 May 2019 (the "**Closing Date**") inclusive. Entries received outside this time period will be void and will not be eligible to win any prize.
- 6.2 In order to enter the Prize Draw, participants must:
 - a) register at <https://f1esports.com/> and link their Xbox Live, PlayStation or Steam gaming account;
 - b) enter the 2019 F1 Esports Series (the "**Competition**"); and
 - c) complete at least one qualification attempt during the qualification round of the Competition.
- 6.3 The winner of the Prize Draw will be contacted via email. All participants must provide a valid email address at the time of entering the Competition. Any entry received without a valid email address will be void and the relevant participant will not be eligible to win any prize.
- 6.4 In entering the Prize Draw, participants confirm that they are eligible to do so. The Promoter may require you to provide proof that you are eligible to enter the Prize Draw.
- 6.5 No purchase is necessary to enter the Prize Draw and purchase of any item does not enhance your chance of winning.

- 6.8 Promoter accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by Promoter.

7. PRIZES

- 7.1 The prize for the winner shall be:
- a) two (2) three-day Grandstand tickets for the FORMULA 1 ROLEX BRITISH GRAND PRIX 2019 on 12th – 14th July 2019 (“**the Event**”);
 - b) two (2) tickets to the 2019 F1 Esports Pro Series Pro Draft at the Gfinity Arena in London on 17th July 2019;
 - c) return economy flights for two (2) from within a reasonable distance from the winner’s residential address (one ticket being for the winner and one for their companion, parent or guardian). Flights will arrive in London on 11th July 2019 and will depart London on 18th July 2019;
 - d) accommodation for two (based on sharing/twin occupancy) within a reasonable distance from the Silverstone Circuit for 12th – 14th July 2019 and from the Gfinity Arena on 11th July and 15th-17th July 2019.
- 7.2 The prize listed above does not include any associated costs or expenses including travel, insurance, transfers to and from airports, stations or ports, food and drink, spending money, or personal expenses. Any other costs incurred in addition to those set out above and that are incidental to the fulfilment of the prize are the responsibility of the winner(s).
- 7.3 Additionally, the winner is solely responsible for:
- a) all applicable federal, state and local taxes, including taxes imposed on his/her income (including in relation to the receipt of the reward, if applicable); and
 - b) all other travel arrangements including procurement of passports, visas and any inoculations.
- 7.4 The approximate retail value for the prizes are as follows:
- a) two (2) three-day Grandstand tickets for the Event approximately valued at £250 per ticket;
 - b) two (2) tickets to the F1 Esports Pro Series Pro Draft are not available for purchase and cannot be valued; and
 - c) hotel accommodation and flights (as defined above in 7.1) value will vary according to flights and accommodation available at the time of booking.

8. WINNER

- 8.1 There shall be only one winner and the winner will be selected by way of a random draw from all entries received in accordance with these Terms and Conditions. The odds of winning will depend on the number of entries received.

- 8.2 The draw will be performed by a random computer process. The draw will take place at Promoter's offices at No. 2 St James's Market, London, SW1Y 4AH no later than 22 May 2019.
- 8.3 The winner will be notified by email no later than 24 May 2019 and given details of how to claim their prize.
- 8.4 If the winner does not respond to Promoter within 7 days of being notified of their win, the winner's prize will be forfeited and Promoter shall be entitled to select another winner in accordance with the process described above (and that winner will also have to respond to notification of their win within 7 days or else they will also forfeit their prize).
- 8.5 If the winner rejects their prize or the entry is invalid or in breach of these terms, the winner's prize will be forfeited and Promoter shall be entitled to select another winner.
- 8.6 Any winner that is below the age of 18 must be accompanied by a parent or guardian in order to collect the Prize.
- 8.7 The decision of the Promoter regarding any aspect of the Prize Draw is final and binding and no correspondence will be entered in to.

16. Promoter shall not be liable for any failure to comply with its obligations relating to this Prize Draw where the failure is caused by something outside its reasonable control.
